PREVIEW MEMBERSHIP AGREEMENT

I, we _____, hereby apply to preview the following membership:

If my membership is approved, I will be entitled to full membership privileges for such membership category through December 31, 2017. There shall be no monthly dues, food minimums or capital assessments incurred by me through July 1, 2017, and no initial initiation fee for the preview membership term through December 31, 2017. By electing to join as a preview Member, I further agree to the following terms and conditions as they relate to my membership category.

1. **Commitment to membership for a minimum preview term through December 31, 2017.** I will be committed to membership within the above category through December 31, 2017. I will be responsible to pay only all of my usage expenses (such as carts, food and beverages) through June 30, 2017. Commencing on July 1, 2017, I will be responsible to pay all applicable monthly dues, fees and charges (including usage expenses) each month during the preview membership term concluding on December 31, 2017. A \$500 deposit is required with your application as part of establishing your member D.A. account. It will be applied against expenses incurred at the club. A non-refundable deposit in the amount of 50% of dues for the period from July 2017 through December 2017, paid with submission of application is also due.
2. **Continuation of Membership.** I shall have the ability to continue my membership with all of its privileges after the conclusion of my preview relationship on December 31, 2017.
3. **Privileges and limitations during preview period.** During the preview relationship, I shall be entitled to the use of the club facilities and involvement in all club activities (including major club tournaments/events as determined by Race Brook Country Club) and usage privileges in the category of membership in which I am approved. Additionally, I understand my preview relationship is not transferable or refundable.
4. **Race Brook Country Club By-Laws.** I agree to be bound by the By-Laws and Rules and Regulations as established and may be amended by Race Brook Country Club from time to time.
5. **Recallable Membership.** The club has the absolute right and discretion to recall my membership at any time before the preview relationship terminates (December 31, 2017, or December 31, 2018). If the club exercises its right, I remain obligated and promise to pay dues and charges incurred through the end of the month in which the club exercises its right to recall said membership. In the event dues are paid in full for the entire preview term, a pro-rata refund will be issued based on the number of months of active membership.
6. **Final Interpretation.** The Board of Governors reserves the right to make final decisions pertaining to all matters regarding the Preview Membership initiative.
